- Queensberry Promotions and BT on their application for a live blocking injunction under s.97A of the Copyright Designs and Patents Act. The injunction required the UK's six largest ISPs to block access to illegal streams of the high-profile 'Wilder v Fury' boxing match in December 2018 as well as future QPL-organised boxing events to be broadcast on BT.
- UEFA on a review of virtual advertising regulations in each of their member jurisdictions; in relation to alcohol restrictions at football matches, including on the consumption, sale and promotion of alcoholic beverages in Belgium, Serbia, Montenegro, North Macedonia and Slovenia; and on several regulatory matters in relation to the hosting of Euro 2020 football matches in the Basque Country (San Mamés stadium).

#### **Regulatory / Dispute Resolution**

- FC Twente Representing the club before the Dutch FA arbitration committee against players agents in disputes relating to commission on the transfer of a number of players to FC Twente.
- FIFA on the Doyen Sports/Seraing cases on the legality of the FIFA prohibition on third party ownership in the context of the sporting sanctions that have been imposed on football club Seraing (transfer prohibition for several transfer windows). The FIFA rules were challenged under EU competition and free movement rules, and under the European Human Rights Convention. In 2019, the Brussels Court of Appeal rejected all claims brought against FIFA.
- First Division Clubs De Graafschap and Cambuur vs Dutch Football Federation (KNVB) As a result of COVID-19 the Dutch Professional Football competitions were prematurely terminated. A decision by KNVB not to apply promotion and relegation was brought before Court in summary proceedings. The clubs argued that the decision was against principles of reasonableness and fairness since both clubs were clearly on their way to promotion with a view to the ranking at the time of termination of the competition.

- Kira Toussaint Supported the top swimmer in challenging the decision of FINA (Fédération Internationale de Natation) to suspend her after what turned out to be a so-called false positive test caused by fully permitted medication that was being used.
- Kjeld Nuis Supported the Dutch speed skater and two-time Olympic champion who was unable to participate in the Dutch Distances Speed Skating Championships in 2019 due to illness. Despite this, the Dutch National Skating Association (KNSB) let Nuis participate in the ISU World Single Distances Speed Skating Championships. Skating competitors disagreed with the decision and went to the arbitration committee of the KNSB to enforce a "skate-off" between athletes.
- Scottish FA Providing lead advice on the drafting, implementation and operation of a detailed set of rules and procedures for Scotland's largest SGB to create a bespoke set of rules which deal with the suitable levels of fairness and natural justice, good governance, separation of powers and appropriate guidelines on sanctions. We recently provided cover as interim compliance officer for the client and were involved in the investigating and prosecting a number of high-profile on-field and off-field matters.
- SIS, Betfred and The Tote on a claim by The Racing Partnership in a complex case relating to the creation and provision of horseracing betting odds and other data relating to horseraces and a number of racecourses in the UK. The judgment involved an unusual application of the law of copyright and database rights to horseracing and, more generally, to the collection and distribution of data, and is of significant relevance to industries which produce and disseminate data to third parties.
