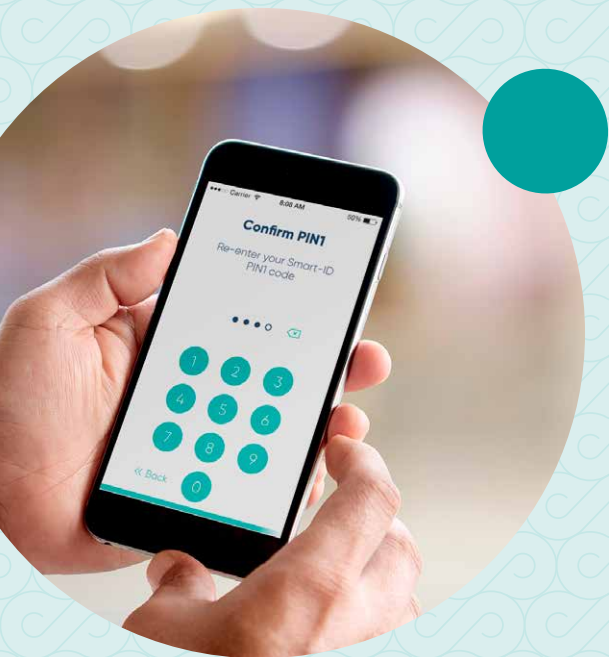

For using Smart-ID, two PIN codes are created:

- **PIN1 code for logging in**
- **PIN2 code for electronic signing**

Smart-ID application does not store PIN codes. User's identity is safe even if the smart device itself is compromised.

Smart-ID's security is based on utilized split key RSA scheme, where user's private key is equally stored in the server and in the app, and proven principles of public key infrastructure and threshold cryptography.
